

**Teradyne, Inc.**  
**Standard Warranties**  
**Assembly Test Division – Commercial**

Teradyne, Inc. (“Teradyne”) warrants for one year that equipment newly manufactured by Teradyne (the “Equipment”) will substantially conform to Teradyne’s applicable published specifications delivered with the Equipment and as updated from time to time by Teradyne in its sole discretion (the "Specifications") and will be free of defects in workmanship and materials (the “Equipment Warranty”). Some Equipment may contain remanufactured parts equivalent to new in performance and such Equipment will be warranted as new Equipment. Factory reconditioned systems may be warranted for less than one year and will be warranted as quoted by Teradyne. Teradyne does not warrant that the operation of the Equipment will be uninterrupted or error free. This Equipment Warranty commences (1) on the date of shipment of the Equipment (if not installed by Teradyne) or (2) on the date of installation of the Equipment (if installed by Teradyne) or (3) six weeks after the date of shipment (if to be installed by Teradyne, but installation has not been completed through no fault of Teradyne). Installation of the Equipment occurs upon successful completion of Teradyne’s installation procedures that demonstrate that the Equipment is able to do useful work [e.g., the completion of Teradyne’s standard operational verification procedures (OVP), interconnect verification procedures (IVP), or other Teradyne standard diagnostic procedures as updated from time to time by Teradyne in its sole discretion], which shall be deemed to have occurred no later than 21 days after shipment of the Equipment unless Customer notifies Teradyne to the contrary. During the Equipment Warranty period Teradyne will service, adjust, or replace any non-conforming part(s) returned under this Equipment Warranty at no charge to Buyer.

For Equipment installed by Teradyne, on-site repair, limited to servicing, adjusting, or replacing part(s), will be performed for a period of one year after commencement of the Equipment Warranty at no additional cost to Customer.

For parts supplied by Teradyne for use in connection with the Equipment, Teradyne’s warranty is 90 days from the date of shipment. Some parts may be remanufactured to function equivalent-to-new.

This Equipment Warranty applies only to normal use of the Equipment and shall be void if Teradyne determines that defects or non-conformities of the Equipment were caused by Customer’s negligence, misuse, or accident; or by the use of parts obtained from third parties; or by unauthorized repair, alteration or installation of the Equipment. This Equipment Warranty does not extend to consumable items (e.g., such as pins and probe tips), or to mechanical parts of the Equipment failing from normal usage. Customer’s sole remedy and Teradyne’s exclusive liability for claims against Teradyne shall be the repair or replacement of the defective or non-conforming Equipment and parts, or, if repair or replacement cannot be accomplished, compensation for direct damages not to exceed the applicable amounts paid by Customer to Teradyne for the Product.

Teradyne warrants that any services provided by Teradyne (the “Services”) will be performed in a good and workmanlike manner (the “Services Warranty”). Customer’s sole remedy for claims and Teradyne’s sole liability under this Services Warranty is for Teradyne to re-perform the applicable Services in conformity with the Services Warranty.

The warranties contained herein are non-transferable.
