Teradyne is committed to complying with all applicable laws and regulations of those countries in which we do business.

EU RoHS 2011/65/EU (Restriction of Hazardous Substances)

Teradyne complies with the European Union's (EU) RoHS Directive 2011/65/EU.

Teradyne's automated test equipment (ATE) is classified as Large-Scale Stationary Industrial Tools (LSIT) under the EU RoHS directive. LSIT is currently out-of-scope/exempt from the directive's substance restrictions.

Teradyne's bench top wireless testers are characterized as professional monitoring and control equipment and comply with the substance restriction provisions in RoHS.

Teradyne has been working to eliminate the six restricted substances in the EU RoHS Directive since the mid-1990s for all of our product lines.

EU WEEE 2012/19/EU (Waste Electrical and Electronic Equipment)

Teradyne complies with the EU WEEE Directive. Teradyne systems (with the exception of LitePoint) are considered large-scale industrial equipment (LSIT) and "Out of Scope" of the EU WEEE Directive.

Equipment which does not qualify as LSIT is appropriately marked with the required "Wheelie Bin" symbol. Teradyne reports annual sales of our WEEE equipment, where applicable, in the respective EU member state.

EU REACH No. 1907/2006 (Registration, Evaluation, Authorization, and Restriction of Chemicals)

Teradyne is committed to the safe use and identification of chemicals per the requirements of EU REACH (Registration, Evaluation, Authorization and Restriction of Chemicals). Teradyne is in compliance with EU REACH and is not required to pre-register.

Teradyne's products are "articles" as defined in 3(3) of REACH, and do not release substances under normal use. We do not have substances present in our products in quantities totaling over 1 tonne per year. None of the currently identified SVHCs (substances of very high concern) on the European Chemical Agency's (ECHA) Candidate List are contained in Teradyne products above the concentration specified.

Teradyne is committed to providing our customers with information regarding substances of concern in our products. We will continue to monitor our products under EU REACH.

China's Administrative Measures for the Restriction of the Use of Hazardous Substances in Electrical and Electronic Products (China RoHS 2)

Teradyne complies with the requirements set forth under China's Administrative Measures on the Control of Pollution Caused by Electronic Information Products. China RoHS requires that all electronic and electrical products that are sold in the People's Republic of China be marked with the appropriate Electronic Information Products (EIP) logo. In addition to the logo, a disclosure table indicating the presence of any of the restricted substances must be provided in Chinese. Teradyne is marking products with the EIP logo and including the disclosure table. Teradyne will continue to monitor China RoHS as it evolves.
